Greetings! First on behalf of the Paumanauke Pow Wow Committee, BACCA, and the Town of Babylon, we wish to thank you for your support of our annual Native American Gathering. We would like you to be a part of our 2026 , "Paumanauke Pow Wow" to be held on Saturday, August 8, 2026 and Sunday, August 9, 2026, at Tanner Park, Copiague New York 11701. Please use Entrance on Wilson Ave.

**CONTRACT RULES AND REGULATIONS**

1. All Vendors must abide by the rules and regulations set forth by the Pow-Wow Committee, or will be subject to ejection from the Pow-Wow, forfeiting their Vendor's fee.
2. Vendor spaces are **about 15 feet wide (frontage) be 20 feet deep**. The **cost is \$300.00** for both days for traders and **\$350.00** for food **vendors**. All Merchandise and Vehicle must be within assigned space. Checks to be payable to: **PAUMANAUKE NATIVE AMERICAN FESTIVAL INC**. All fees are non-refundable. **IF CONTRACTS ARE RECEIVED AFTER DEADLINE A \$50 LATE FEE WILL BE ADDED!**
3. No alcohol or illegal drugs, profanity or vulgarity will be tolerated. This is a family event. We have an image to PROJECT and PROTECT!
4. Trader participation is by invitation only; no one will be allowed to set up without an executed contract by Paumanauke Native American Festival Inc.
5. NO DISCOUNT or SALE SIGNS will be posted; NO HANDBILLS or FLYERS will be circulated without prior, written Committee approval.
6. This is a Town Park, ABSOLUTELY!!! NO PETS are permitted on Pow Wow Grounds! So please leave pets at home. All State, County, Town Ordinances must be obeyed.
7. Contracted Vendors will not sublet their assigned space (s) for a fee, sharing of space will be by prior arrangement with the event committee only. ANYONE other than the contracted Vendor who attempts to set up will be asked to leave, along with the contracted Vendor, forfeiting the Vendor's fee.
8. No misrepresented Silver work, leather items, imported beadwork or other mass produced or quasi Indian items will be permitted! A partial list of prohibited items includes, but is not limited to: ***rubber tomahawks, toy bow and arrows, and spears. No face painting will be allowed.***
9. The Pow Wow Committee reserves the right to remove any item judged to be offensive. Any Vendor refusing to comply with a request to remove any items or items in violation of this contract will be asked to leave, and their fee will be forfeited.
10. NO Vehicles Permitted On the Grounds. All Vehicles Must be Parked in Vendor Parking Area.

11. Booth assignments are arranged by the Pow Wow Committee and cannot be changed, NOR TRANSFERRED, without prior approval of the Committee.
12. Receipt of this contract does not guarantee a Vendor's space.
13. It is the responsibility of the Vendor to keep his/her assigned area free from trash at all times, both during and after Pow-Wow.
14. Please be Advised that Paumanauke Native American Festival Inc., Its Staff and Pow Wow Committee are **NOT and Will NOT be Held responsible** for Theft, Damage, Accidents or Injuries to personal Property or Person/s. You the Vendor take full responsibility of any or all claims to damage, theft, accidents or Injuries.
15. All Native jewelry or art for sale should be authentic as defined by the Indian Arts and Craft Act of 1990 (P.L. 101- 644).

16. No illegal feathers, bones, fur, or other animal parts are to Be Sold. If you are unsure of state or federal regulations, please contact the New York State Wildlife and Fisheries before attending. Paumanauke Native American Festival Inc. or its staff / Members will NOT be held responsible if the New York State Wildlife and Fisheries Fines You for your Illegal Sale of these Items or if you have them in your possession. **IT IS YOUR RESPONSIBILITY!**
